

# **Chest Refrigerator**



## **General Information:**

Your chest refrigerator was designed by the Frenzel GmbH and made according to the best available technology.

It is made of high quality materials and was thoroughly tested at the factory.

Prior to operating the appliance, please pay attention to the following issues.

## **Assembly:**

Prior to installing the appliance in the intended space, please check whether the pipes located inside the appliance were bent during transport and are touching the compressor or the side of the refrigerator.

This would cause disturbing noises during operation.

Carefully bend them away, if necessary.

The appliance must always remain firmly installed and must stand level. Unevenness in the floor must be evened out.

Carefully read the installation instructions prior to installing and operating the appliance and only use the appliance for the purpose described in the operating instructions.

## **Important**

When operating the appliance, please pay attention to the following issues. You will thus prevent damage and avoid loosing possible warranty claims.

This appliance is intended for use in motor vehicles. If the refrigerator is used for industrial purposes the respective applicable trade regulations must be observed.

Don't store any explosive materials in the appliance. High proof alcohol shall only be stored in closed and standing containers.

## **Prior to operation**

For reasons of hygiene and health it is recommended to thoroughly clean the refrigerator.

# **Operation**

The air supply to the cooling unit must always be warranted and shall not be blocked by objects.

The desired cooling is selected with the temperature selector located inside the chest refrigerator.

Apart from the setting on the temperature selector, the temperature in the refrigerator depends also on the ambient temperature, the amount of food stored, and how often the refrigerator is opened. This is why we cannot provide exact temperatures.

# **Temperature Selection**

Setting on "0", cooling is switched off.

Setting on "3", results in minimum cooling.

Setting on "5", results in medium cooling.

Setting on "7", results in maximum cooling

## Cleaning

Switch your appliance off. Keep the condenser free of dirt by regularly cleaning the lamellae with a soft brush or blow them out with compressed air, if available. The dirt can also be vacuumed with a vacuum cleaner.

Pay attention that no water runs into the temperature selector, the press switch and the interior light.

Don't use strong and abrasive cleaning agents, also no soap (smell).

Wipe down the inside and outside of appliance with warm water containing just a little mild cleaning agent. Wipe down with clear water and dry.

#### **Defrost**

Set temperature selector to "0". The appliance is shut off. Empty the refrigerator.

## **Shutdown**

If you don't use the appliance over an extended period of time:

- Set temperature selector to "0". The refrigerator is shut off.
- Defrost refrigerator.
- Clean refrigerator.
- Leave the refrigerator lid open (otherwise odours will form).

# What to do if...

Fault	Possible Cause	Remedy
Compressor doesn't run. The diode (provided there is one) between <b>C</b> and <b>D</b> (wiring diagram) is blinking.	Voltage on terminals for electronics is too low. Disconnection due to accumulator protection.	Use wires with larger cross section between electronics and accumulator.     Eliminate loose connection on connector.     Eliminate oxidation on contacts
	Accumulator voltage is too low.	Charge accumulator.
Compressor doesn't run.	Thermostat.  Defective fuse due to incorrectly connected poles on the terminals for electronics.  Fuse on E-panel of coach is	Is thermostat connected to <b>C</b> and <b>T</b> and does it function properly?  Transpose input leads to electronics. Replace fuse.  Replace fuse.
	defective.	Replace rase.
Compressor (fan) still doesn't run after defective fuse has been replaced.	Electronics or compressor defective.	Replace electronics system. If the compressor starts the old electronics system is defective.
	Fan is defective.	Disassemble fan. If the compressor starts the fan is defective.
Compressor (fan) doesn't run, however it attempts to start.	Room temperature is too high (more than 55°C), electronics on compressor is too hot.	Bring temperature inside of compressor installation compartment down below 55°C.
	Condensation temperature too high.	Clean condenser (lamellae).
	Pressure equalisation didn't occur, the standing time is too short.	Increase thermostat difference or install 1-2 mm plastic panel between sensor and evaporator
	Fan is blocked or a load of more than 0.5 Ams continuously or 1 Apeak during the starting process is put on the electronics system.	Replace fan with fan model requiring less than 0.5 $A_{\text{ms}}$ continuously or 1 $A_{\text{peak}}$ during the starting process.
Partially reduced or no cooling capacity. Increased temperature in refrigerator. Compressor runs	Partially escaped refrigerant, leak in cooling system.	Eliminate leak, replace filter dryer, evacuate cooling system and refill refrigerant.
continuously.	Capillary tube partially clogged (moisture in cooling system).	Replace filter dryer, evacuate cooling system and refill refrigerant.

## Warranty


MOLPIR s.r.o. will guarantee the appliance for two years.


